Contract

This contract is an agreement between **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)** and _____
For pet care services beginning on _____, and thereafter on an as-needed basis. **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)** agrees to provide pet care services to the Customer in a reliable, trustworthy, and caring manner.

PET CARE

1. I, _____ authorize **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)** to perform pet care services as outlined on the “Policy and Guideline Sheet” which shall become part of this contract.
2. If the pet(s) become ill while under the care of **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)**, I authorize the sitter designated to care for my pet(s) by **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)** to transport my pet(s) to my veterinarian (or one who is available) if this is needed in his/her best judgment. I authorize **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)** to approve any emergency treatment recommended by the veterinarian and I agree to pay promptly for any charges incurred. I release **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)** from all liabilities related to transportation, treatment, and expense.
3. In the event of inclement weather I authorize the sitter assigned by **Aunt Jeanne - Pet Nanny (division of JDR Enterprises, Ltd.)** to use his/her best judgment in caring for my pet(s) and home.
4. When weather conditions are less than favorable, i.e. pouring down rain, icy conditions making it very slippery, or excessive heat, walks may be limited for the safety of your pet.

PAYMENT

1. For mid-day walks, payment is due Every Monday for the upcoming week.
2. For vacation travel, payment is due in advance, before traveling occurs.
3. There will be a \$25.00 returned check fee.

LIABILITY

1. Customer expressly waives and relinquishes any and all claims against **Aunt Jeanne - Pet Nanny (A division of JDR Enterprises, Ltd.)** and associates, except those arising from negligence on the part of **Aunt Jeanne - Pet Nanny (A division of JDR Enterprises, Ltd.)** .
2. It is expressly understood and agreed that **Aunt Jeanne - Pet Nanny (A division of JDR Enterprises, Ltd.)** shall not be held responsible for any damage to Customer’s property, or that of others, caused by Customer’s pet(s) during the period in which they are in its care. I have advised **Aunt Jeanne - Pet Nanny (A division of JDR Enterprises, Ltd.)** of other situations that will relieve it of liability for damage.
3. If a dog or cat has a history of biting, **Aunt Jeanne - Pet Nanny (A division of JDR Enterprises, Ltd.)** reserves the right to refuse service. Bites must be reported to the local authorities as provided by law. The owner will be liable for the sitter’s medical care expenses and damages that result from an animal bite.
4. In the event that a dispute regarding a liability issue results in a court case, I agree to be responsible for all attorney’s fees and court costs incurred by **Aunt Jeanne - Pet Nanny (A division of JDR Enterprises, Ltd.)** in defending the action of the judgment if ruled in the Pet Sitting Service’s favor.
5. Client expressly releases **Aunt Jeanne - Pet Nanny (A division of JDR Enterprises, Ltd.)** from liability due to: a) damage by the pet(s); b) injury, disappearance, death, or fines incurred due to the pet’s access to the outdoors; c) any complication in administering medication to the pet; or d) the actions (or infractions) of persons having access to the Client’s premises.
